Remarks:

1. Basis of preparation

The condensed consolidated results have been prepared in accordance with accounting principles generally accepted in Hong Kong and comply

with accounting standards issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). They have been prepared under the historical cost convention.

In 2004, the HKICPA issued a number of new and revised Hong Kong Accounting Standards and Hong Kong Financial Reporting Standards ("HKFRS") which are effective for Accounting periods beginning on or after 1st January 2005. The adoption of these HKFRS has no material impact on the Group result of operations and financial position.

The consolidated results are unaudited but have been reviewed by the Company's audit committee in accordance with rule 5.30 of the Gem Listing rule.

2. Profit/(Loss) per share

Profit/(loss) per share for the nine months and three months ended 30 September 2005 are calculated based on the Group's loss attributable to the shareholders of HK\$5,871,000 and HK\$2,373,000 respectively. (Loss attributable to the shareholders for the corresponding period in 2004: HK\$571,000 and HK\$850,000 respectively) and on the weighted average number of 204,000,000 shares (2004: 204,000,000 shares) in issue during the periods.

Diluted Profit/(loss) per share was not presented because there were

no potential dilutive ordinary shares in existence during the nine

months ended 30 September 2005 (2004: Nil).
